OPENING REMARKS OF MS. DEBORAH STOKES (VICE-PRESIDENT FOR ADMINISTRATION AND CORPORATE MANAGEMENT)

Constitutional questions will also be raised.

It is very clear that judiciaries will have an important role to play in shaping how countries address climate change.

This year's Roundtable also seeks to further strengthen the relationships among Chief Justices which have been cultivated over the last six years.

This is why the Philippine Supreme Court and ADB have included in the program a session on the role of judicial networks in promoting mutual assistance.

We hope this discussion will help you to consider how to institutionalize the Chief Justices' Roundtable within the ASEAN framework.

I wish to again welcome you to the 6th ASEAN Chief Justices' Roundtable on Environment.

ADB is delighted to host all of you in the beautiful island of Palawan, and we are grateful for the leadership you have shown.

I am confident that the discussions over the next two days will be robust and frank, and arguments will be well-considered, demonstrating once again your leadership role in addressing environmental issues.
